Ethel Guttenberg joined Huntington, New York NOW when her children were young and remained an active member for many years. After moving to Ohio from the Bronx, New York, she immediately became a member of Cincinnati NOW and has held many leadership positions.

Ethel's family suffered two major tragedies in the last year. Her son, Dr. Michael Guttenberg, died in October 2017 from pancreatic cancer that was associated with toxin exposure related to working as a rescuer on 9/11 at the World Trade Center. Her 14 year old granddaughter, Jaime Guttenberg, was one of the students murdered during the high school shooting on February 14, 2018 in Parkland, Florida.

Ethel had been active in Moms Demand Action since the Sandy Hook shooting but she never imagined that one of her own grandchildren would become a victim of gun violence. She will continue to dedicate her life to making Jaime's memory a blessing with her fierce advocacy work that aims to protect all of our children from gun violence.



Fred Guttenberg was

recovering from the death of his brother Michael, when on February 14, 2018 Fred and his family were again struck by another tragedy. His 14 year-old dauther, Jaime, a freshman at MSD HS, was one of the 17 victims brutally murdered in the Parkland school shooting.

From that day forward, Fred's life would be forever changed. While grieving, Fred found himself unable

to stand still. The day after the murder, he attended a vigil and while there was asked to speak. That was the start of a new public life for Fred. He was angry and quickly realized his new purpose as an American advocate in the fight for public safety.

Fred now spends time challenging our elected officials to do more and he is aggressively pursuing strategies to enhance public safety, enact common sense gun safety and turn out the vote through his non profit organization dedicated to Jaime's life called "Orange Ribbons for Jaime". Through the formation of the non-profit, this is now his full time mission. Fred's leadership and perseverance in spite of these dual tragedies is and his ability to turn the worst possible grief into action and to attain ongoing results is now nationally known.



Arlene R Ustin was raised in The Bronx with a sharing/serving ethic. Her nature is outgoing, seeking to assuage injustice and unkindness whenever she finds herself in position to do so.

Arlene's 45-year professional career was in education: from a public junior high school in the blighted neighborhood rated first in fires, homicides, and thefts by the New

York Times in the '60s, to the North Carolina Outward Bound School in the '70s as its first woman program specialist and finally onto the college prep Athenian School for 28 years directing unusual graduation requirements and designing specialized courses to the graduate faculty of the Department of Alternative Education in the Master of Arts Program at Prescott College in Arizona.

Whether in an inner city, the wilderness, or a suburban landscape. Arlene has recognized and honored diversity and inclusion in its myriad complexities, seeking to present opportunities to each student so that they can develop their unique potential, encouraging the pursuit of excellence in worthy endeavors, and responding to issues of social justice are the qualities in her work that she brought to Florida in 2006.

Arlene describes herself as a humble, but firm and fearless, advocate/activist. She is a member of NOWPBC (served as President for two terms; currently Vice President & Program Chair), serves on several LWVPBC committees, is captain of two Democratic Precincts, and is a founding member of the Committee Against Gun Violence (CAGV). She volunteered for Obamacare, worked to combat sex trafficking, and participates in rallies, demonstrations, and campaigns to protect the environment, immigration rights, and promote citizen initiated petition drives to be the voice of those who have none.



Gail Schwartz was thrust into the national gun debate after her nephew, Alex Schachter, was killed by an AR-15 while sitting at his desk in language arts class in Parkland, Florida on Valentine's Day 2018.

Since then, she has started a political committee, Ban Assault Weapons Now, to place a Florida constitutional amendment banning assault weapons on the 2020 ballot.

A citizen's initiative does not require legislative approval. Floridian's can amend the constitution by collecting the nearly 800,000 required signatures. BAWN has formed a bipartisan coalition with Ambassador Al Hoffman and his group, Americans For Gun Safety Now. Together, we will make up for the failures of our elected officials to keep our children and communities safe. We are done waiting!
