## VOTER FACTS

The next **General Election** is Tuesday, November 8, 2022, to elect all state officials. The **Primary Election** is Tuesday, August 23, 2022.

**Early Voting** is October 29-November 5 for the General Election and August 13-20 for the Primary Election. Counties may have additional Early Voting days.

### YOU CAN REGISTER TO VOTE IF...

- You are a U.S. citizen and are at least 18 years old. 16- and 17-year-olds may pre-register to vote.

- You are a legal resident of Florida and the county where you will vote.

- You have no felony convictions: unless civil rights have been restored

- You have not been judged mentally incapacitated.

NOTE: You must be registered at least 29 days before Election Day.

As a result of the passage of Amendment 4, felons may register to vote if...

- They are Florida residents and U.S. citizens.

- The felony conviction was not murder and not a felony sexual offense AND

- They have completed their sentences in full, including all fines and fees that were part of that sentence.

### VOTER INFORMATION CARD

- Contains your precinct number and polling place.

- Contains your District numbers for U.S. House, Florida Senate, Florida House, County Commission and School Board.

### 3 WAYS TO VOTE

#### Early Voting

- All early voting sites are available to all Palm Beach County voters, regardless of precinct. **Photo ID with signature is required.**

#### Vote by Mail

- Vote by mail (absentee) ballots are available to all registered voters in Florida. Request online at [www.pbcelections.org](http://www.pbcelections.org), or call 561-656-6200.

#### Vote on Election Day

- Polls are open from 7AM-7PM. Voting is allowed in assigned precinct only. **Photo ID with signature is required.**

### PRIMARY ELECTIONS

- Florida is a closed primary state. Only voters registered in a political party may vote for that party's candidates.

- Judicial and School Board candidates, and Constitutional Officers that are non-partisan may be on primary ballots. All registered voters (regardless of party affiliation) may vote for these candidates.

### SPECIAL FACTS

- For early voting, please check with the Supervisor of Elections for dates, times and locations. Call 561-656-6200 or check online at [www.pbcelections.org](http://www.pbcelections.org).

- If a ballot is spoiled, a voter may have up to two additional ballots.

- A voter who does not show ID or whose eligibility is questioned is entitled to vote a Provisional Ballot that will be set aside to be validated.
